Pursuant to BAC Infra Resolution No. 2017-09-071, Bidders should own at least one of each kind of the minimum required equipments, particularly: Backhoe, Dump Truck, Bulldozer, Pay Loader and Transit Mixer. Also, the only authorized person to buy and drop the bid documents is the bidder himself or his authorized representative through a Special Power of Attorney (SPA).

Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II – Instruction to Bidders. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

Bidding will be conducted through open competitive procedures using non – discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184). Otherwise known as the “Government Procurement Reform Act”

Bidding is restricted to Filipino Citizens/sole proprietorships, or organizations with at least seventy five percent (75%) interests or outstanding capital stock belonging to citizens of the Philippines. Interested bidders may obtain further information from the Provincial Government of Benguet through the Bids and Awards Committee on Infrastructure and inspect the Bidding Documents at the address given during office hours, Monday to Friday. A complete set of bidding documents may be purchased by the interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount tabulated below.
