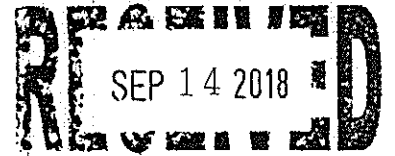

RESOLUTION NO. 18 - 418

DECLARING THE PROVINCE OF BENGUET UNDER THE STATE OF CALAMITY

WHEREAS, the Province of Benguet has been struck by a Southwest Monsoon "HABAGAT" enhanced by Tropical Depressions "Henry", "Josie" and lately "Luis" for the period July 17, 2018 to August 27, 2018, or for a period of more than one month;

WHEREAS, the compounded effect of the Southwest Monsoon is so devastating that caused the loss of lives, great damages to crops, properties, animals and infrastructures worth millions of pesos;

WHEREAS, in letter dated August 31, 2018 of Hon. Crescencio C. Pacalso, Provincial Governor, submitting a summary report from the Rapid Damage Assessment and Needs Analysis (RDANA) Teams, to wit:

WHEREAS, the monitored / reported casualties were five (5) dead, eight (8) injured and one (1) missing person in Mankayan, Benguet, 222 totally damaged houses and 59 partially damaged houses with a total 286 families affected. The following are the reports submitted;

WHEREAS, there is a need to declare the entire Province of Benguet under the State of Calamity due to the damages caused by the onslaught of the Southwest Monsoon;

NOW THEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby done, to declare the Province of Benguet under the State of Calamity;

RESOLVED FURTHER AND FINALLY, to forward this resolution to Hon. Crescencio C. Pacalso, Provincial Governor, for his appropriate action. Let copies hereof be furnished the different municipalities of Benguet, all concerned departments of the Province and the Provincial Auditor, all for their information.






