THIS AGREEMENT, made this ____ day of FEB 24 2021 between HON. MELCHOR D. DICLAS, MD., Provincial Governor, Province of Benguet, Provincial Capitol, La Trinidad, Benguet, (hereinafter called the "Entity") and EUGENIO AGLASI, Manager of EUGAO CONSTRUCTION with officer address at Palasaan, Mankayan, Benguet, (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the project, entitled: **IMPROVEMENT OF POSDO 1 & 2 DOMESTIC WATERWORKS, TABIO, MANKAYAN, BENGUET** (hereinafter called "the Works" and the Entity has accepted the Bid for **ONE MILLION NINE HUNDRED NINETY-FIVE THOUSAND SIX HUNDRED TWENTY-THREE PESOS AND FIFTY-SIX CENTAVOS (Php1,995,623.56)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. In consideration for the sum of **ONE MILLION NINE HUNDRED NINETY-FIVE THOUSAND SIX HUNDRED TWENTY-THREE PESOS AND FIFTY-SIX CENTAVOS (Php1,995,623.56)** or such other sums as may be ascertained, EUGENIO AGLASI agrees to execute the works of the contract until its completion and provides remedy for any defects therein in accordance with his Bid.




