Interested Bidders are required to obtain prescribed bid forms from the Disposal Committee Secretariat, Provincial General Services Office (PGSO) Capitol Basement, La Trinidad, Benguet from **May 9, 2024 to May 30, 2024** during **office hours** and to be submitted **not later than 2 o'clock in the afternoon of May 30, 2024**. **Late bids shall not be accepted.**

TERMS AND CONDITIONS

1. Bid envelopes must be sealed and marked indicating the name, business or address and signature of the bidder and address it to the Chairman of the Disposal Committee;
2. Bid tenders in sealed envelope shall be accompanied by a **bidder's bond in cash or manager's/cashier's check in the amount equivalent to at least 10% of the total bid**. Such deposit shall be returned to the losing bidder without interest as soon as the winning bidder has been determined;
3. **Sale shall be per line item and bid tender should not be lower than the indicated floor price** on an "as-is-where-is" basis;
4. Award shall be given to the highest complying bid; the winning bidder shall be notified by the Disposal Committee;
5. All bids shall be in Philippine currency and the bidder shall state in words the amount of his/her bid;
6. Each bid must be accompanied by machine copy of proof of valid identification card of the bidder;
7. Actual Weighing maybe done for items to be sold in kilograms;
8. The Disposal Committee reserves the right to reject any or all bids, waive any formal defects contained thereto and accept such bids as may be considered most advantageous to the government;
9. The winning bidder shall be required to pay in full upon receipt of Notice of Award, the Awardee shall pay to the local treasurer the amount of the award for which an official receipt shall be issued;

10. In case of unjustifiable refusal of the winning bidder to accept the awarded price within five (5) days from receipt of the official notice of award, the bidder's bond posted shall be forfeited in favor of the Provincial Government of Benguet.
